

NOTICE TO WOODCLIFF LAKE DOG AND CAT OWNERS

Dog and cat licenses must be obtained by January 31, 2010. All dogs and cats over 7 months of age are required to be licensed in the Borough of Woodcliff Lake. A canvass will be made after this date, and owners of unlicensed animals will be subject to the penalty as provided by law. There will be a late fee of \$10.00 in addition to the regular licensing fee after January 31, 2010. After 03/31/10 summons will be issued to owners who have not registered their pets.

Licenses may be obtained at the Borough Hall or by completing the attached application cards and mailing same with a check for the appropriate amount, together with a valid rabies certificate. Please include stamped self-addressed envelope to:

There is a ordinance in effect which will subject you to a \$50.00 fine, if you do not properly dispose of your pet's waste while walking your dog.

THE FREE RABIES CLINIC this year will be held on Saturday January 9, 2010 at the Firehouse between 1:30 and 3:30 P.M. Dog and cat licenses will also be issued at this time at the Borough Hall. It is preferable that you pay by check to expedite the transaction.

APPLICATION FOR DOG REGISTRATION AND LICENSE

Under NJ State requirements, a **Certificate of Rabies Inoculation** Must be Presented with this Application. The rabies certificate has to be **valid at least through November of 2010**. If mailed, it will be returned to you with the Dog License.
