APPROVAL OF MINUTES

MOTION to approve the Minutes of July 17, 2023 (Open) was made by Councilman Schnoll, second by Councilwoman Gadaleta and approved by Councilwoman Gadaleta, Councilwoman Higgins, Council President Margolis, Councilwoman Marsh, Councilman Pollack, and Councilman Schnoll.

MOTION to approve the Minutes of July 17, 2023 (Closed) was made by Councilwoman Gadaleta, second by Councilwoman Higgins and approved by Councilwoman Gadaleta, Councilwoman Higgins, Council President Margolis, Councilwoman Marsh, Councilman Pollack, and Councilman Schnoll.

PUBLIC COMMENT

MOTION to open to the public was made by Councilwoman Marsh, second by Councilman Pollack and unanimously approved.

Mayor Rendo stated that we have a situation that was discussed at the last Mayor and Council meeting regarding a tree at 21 Lincoln Avenue.

The neighbors stated that the tree is problematic. It is a large, diseased tree. They had it trimmed, and they were told by the tree company that the tree is hollow on the inside. If the tree falls it will fall on their house and garage. The acorns are doing damage to the cars. Ms. Catani stated that the tree is a nuisance. Her mother slipped on an acorn and tore her meniscus. The base of the tree is on the neighbor's property. They need permission from the town to take the tree down.

Administrator Padilla stated that Mr. Garcia, Shade Tree inspector, was at the property and originally denied the permit for that tree because it is a heritage tree. Mr. Padilla asked if they informed Mr. Garcia that the tree is hollow. Mr. Padilla stated that the owner has 10 days to appeal a denial. Therefore, the property owner must apply again.

Mayor Rendo stated that he would like to get these people relief and the Council can override the decision.

Motion was made by Councilman Schnoll, second by Councilwoman Gadaleta to pass a Resolution to allow the tree to be taken down.

Stephanie Wong, Woodcliff Lake, stated that she had a few questions regarding air traffic noise. Mayor Rendo replied that the FAA changed the flight pattern, but the pilot still has the choice on which pattern they wish to use. All residents must continue to complain about the air traffic noise.

MAYOR'S REPORT

Mayor Rendo reminded all residents to please fill out the vacant house card so that the police department can properly check on your house while you are away. Additionally, if you have a ring doorbell, please take out the subscription to record and make sure that you register with the police department.

COUNCIL REPORTS

Councilwoman Marsh stated that camp just concluded. Councilwoman Marsh and Councilman Pollack participated in the camp Olympics. Councilwoman Higgins participated in the talent show. USA Sports will be hosting tennis lessons at the tennis courts this fall for all ages. Please check our website for updates. There is a safety demonstration at the pool tomorrow. This will be very informative and everyone over the age of 18 is welcome.

Councilman Pollack stated that our DPW is maintaining the fields and preparing for leaf season. The last leaf pick-up will be on December 5, 2023. The shredding event will take place on October 22, 2023 at DPW. We will have having an in-house meeting this week regarding social media and how we can increase our social media. Mr. Pollack stated that he along with Mayor Rendo, Administrator Padilla and Councilman Schnoll met with NJ Transit regarding improvements to the train station.

Mayor Rendo stated that he spoke with the owners of 188 Broadway regarding the maintenance of their lawn, weeds, etc. They stated that they will address it and look into doing some lawn maintenance on the other side of Broadway.

Councilwoman Gadaleta stated that the fire department has been training at the fire academy. The Fire Department's dinner will be held next month, and they will be honoring Mr. Schuster for his 50 years of service.

Councilwoman Higgins stated that she and Councilman Schnoll will be at Borough Hall on August 31, 2023 from 7PM to 8PM for any resident that wishes to come in and speak with them. Our tax bills have arrived, and you have until September 15, 2023 to pay. Motor Vehicles will be at the Tice Senior Center on August 31, 2023, from 9AM to 3PM and again on September 19th and October 24th. Our building department is suggesting that pool alarms be installed on all new pools. We are still working on our sign for the causeway.

Council President Margolis stated that there is a Resolution on the Agenda tonight for pickleball. We are also looking into purchasing another gaga pit. Our Woodcliff Lake Pool Party is on Labor Day from 11AM to 6PM. This is open to all Woodcliff Lake residents. There will be food and drinks for sale by Café Agnello. We are working on Halloween and Oktoberfest events. We welcome all volunteers. If you are interested in helping us, please let us know.

ADMINISTRATOR'S REPORT

Administrator Padilla stated we will be having a pool safety demonstration at the pool tomorrow. We will be approving the contract for the Glen Road project. Work most likely will not be done until the spring. There is also a Resolution on the Agenda to authorize our engineer to do a survey on the property that we own at 55 Woodcliff Avenue. Administrator Padilla stated that he will be in Hilton Head to give Coach Luciano his Proclamation for his 100th birthday.

AUGUST 2023 ENGINEERS REPORT
BOROUGH OF WOODCLIFF LAKE
AUGUST 10, 2023



1. Glen Road Bridge (NJDOT Funded)

Contract awarded to CMS Construction in the amount of \$1,038,644.00. The Borough of Woodcliff Lake received a grant allotment of \$600,000.00 from the Transportation Trust Fund to partially fund the project. Preconstruction meeting held 5/24/23. Shop drawings have been supplied and were reviewed and approved by Neglia for the culvert and associated materials. Ongoing utility coordination with PSEG (Electric and Gas), Verizon, and Park Ridge Water for utility relocations to be completed prior to bridge demolition. Contractor to provide updated construction schedule pending coordination with above referenced utilities.

2. Glen Road Improvements Project NJDOT FY 2022

The Borough of Woodcliff Lake received a grant in the amount of \$206,000.00 from the NJDOT to be utilized towards the repaving of a portion Glen Road. Neglia completed bid documents in accordance with our proposal and Resolution No. 23-117 and completed NJDOT required pre-bid submission. Bids opened on 8/9/2023 and award recommendation package provided for Borough & Attorney review with intent of awarding the project to Macchione Paving to satisfy the NJDOT October 2023 award deadline with paving to occur early 2024 with schedule to be coordinated with the Borough.

3. Werimus Lane Pump Station Flood Resilient Improvements

Neglia proceeding with the design of the Werimus Lane Pump Station Flood Resilient Improvements project in accordance with our proposal and Resolution No. 23-157.

4. Old Mill Driveway and Bank Stabilization Repairs

Sanzari provided revised proposal for repairs consisting of streambank stabilization repair, permanent infrastructure repairs, and proposed mitigation measures to address area between Old Mill Pond outlet and the access driveway adjacent to the Old Mill Pond Pump/Filter house that was impacted and damaged by Hurricane Ida in the amount of \$224,500.00. Neglia working on survey base mapping in order to file NJDEP Land Use permits asap for the work as required in accordance with our Engineering proposal dated 5/12/2023 and Borough Resolution No. 23-159.

5. Stormwater Outfall Repairs

Sanzari provided revised proposal for repairs to five (5) storm drain outfalls impacted and damaged by Hurricane Ida in the amount of \$150,000.00. Neglia working on survey base mapping in order to file NJDEP Land Use permits asap for the work as required accordance with our Engineering proposal dated 5/12/2023 and Borough Resolution No. 23-159.

6. Galaxy Gardens Civil Design and NJDEP Land Use Permitting

NJDEP Land Use Permit 5-year Extension request for Phase I restoration work was received from NJDEP on 7/27/23 to grandfather in the prior use land coverages as the project site. Neglia coordinating NJDEP permit plans with DMR and permit applications for new park work in accordance with our proposal and Resolution No. 22-197 for the Phase II park improvements and anticipate submitting to the NJDEP by the end of August for the Land Use Permits required for the new park work.

7. Campbell Avenue Paving Project NJDOT MA-2023 & Year 2023 Municipal Paving Project

The Borough of Woodcliff Lake received a grant in the amount of \$203,110.00 from the NJDOT for Campbell Avenue Paving Project as per the November 23, 2022 grant award letter. Revised proposal for bid document preparation, construction management and NJDOT project administration for the combined Campbell Avenue Paving Project & Year 2023 Municipal Paving Project (Birchwood Drive, Stacey Lane, Renee Court) was provided for Borough approval. We intend to bid the Campbell Avenue Paving Project MA-23 and Year 2023 Municipal Paving Project as one bid package to attempt to receive the most favorable bid pricing for the Borough. **As a reminder, the Campbell Avenue project will need to be awarded by November 2024 in accordance with the NJDOT MA2023 grant requirements. NEA is prepared to begin immediately with survey and design upon authorization by the Borough.**

8. Year 2022 Road Program - Marjo Court and Hillcrest Road Paving Project

Repairs to Lydecker wall were completed. Milling and paving of Marjo Court, Hillcrest Road, and Overlook repairs were completed. Spot repairs to Rose Avenue were completed. Project construction has been substantially completed by 4-Clean Up with only invoicing, verification of final quantities, and project closeout documents remaining.

9. Woodcrest Drive Pumping Station

Pump station is up and running. Project is substantially complete pending final restoration.

10. 55 Woodcliff Avenue

Neglia prepared a preliminary concept plan back in 2019 showing proposed parking on the subject property. Neglia can provide a proposal for additional conceptual engineering services to prepare an updated concept plan showing alternative usage of the property for potential storage building and parking upon request.

ORDINANCE NO. 23-12

AN ORDINANCE TO AMEND CHAPTER 5 ENTITLED "ADMINISTRATION OF GOVERNMENT" OF THE
BOROUGH CODE OF THE BOROUGH OF WOODCLIFF LAKE, STATE OF NEW JERSEY

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WOODCLIFF LAKE IN
THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:

WHEREAS, Chapter 5, of the Code of the Borough of Woodcliff Lake sets forth all regulations
regarding the Administration of Government within the Borough of Woodcliff Lake; and

BE IT ORDAINED, by the Mayor and Council of the Borough of Woodcliff Lake, County of Bergen,
and State of New Jersey that those portions of the aforesaid set forth below are hereby amended
as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

ARTICLE XII. Police Department

5-44. Contracted Extra-Duty Employment.

D. Rates of compensation; administration fee; payment for services. Rates of compensation for
contracting the services of off-duty law enforcement officers shall be calculated as follows: (a) a
rate equal to that of a first-class patrolman as per the then present contractual hourly rate or the
employee's applicable overtime rate, whichever is greater. All off-duty law enforcement services
shall be paid a minimum of (4) four hours and all requesting entities must give a minimum of 2
hours prior notice of cancellations of said services or be charged the minimum four (4) hours; (b)
an additional fee of 15% of the rate as calculated above is hereby established to cover
administrative cost, overhead and out-of-pocket expenses of the Borough; (c) an additional fee of
\$20 per hour shall be charged for the use of any vehicle during the extra duty work; and (d) any
and all County work mandates the county rate of pay.

Severability All provisions of this Ordinance are severable. If for any reason, any provision of this
Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

Effective Date. This Ordinance shall become effective upon final approval and publication, pursuant to law,
and upon completion of all outstanding cases.

A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12

**RESOLUTION NO. 23-182
AUGUST 21, 2023**

WHEREAS, the Borough of Woodcliff Lake is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq., and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Borough of Woodcliff Lake to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

_____1. Matters Required by Law to be Confidential. Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

_____2. Matters Where the Release of Information Would Impair the Right to Receive Funds. Any matter in which the release of information would impair a right to receive funds from the Government of the United States.

_____3. Matters Involving Individual Privacy. Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing,

relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.

___4. Matters Relating to Collective Bargaining Agreements. Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.

___5. Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds. Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed specifically with respect to _____. The minutes will be released on or before _____, 20__ when the issues pertaining to the property located at _____ have been approved and finalized.

___6. Matters Relating to Public Safety and Property. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

X 7. Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege, any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer, specifically with respect to: Litigation, Contract Negotiations and Personnel

The minutes will be released in approximately ninety (90) days or upon the resolution through settlement or court decision and the time period for any and all appeals.

___8. Matters Relating to the Employment Relationship. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting, specifically: personnel discussion.

The minutes will be released within ninety (90) days or earlier upon the resolution of the matter through settlement or court decision and the time period for any and all appeals.

_____9. Matters Relating to the Potential Imposition of a Penalty. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Woodcliff Lake, assembled in public session on August 21, 2023 that an Executive Session closed to the public shall be held on August 21, 2023 at 6:00 P.M. at the Borough of Woodcliff Lake Tice Senior Center regarding the discussion of matters relating to the specific items designated above.




