



**BOROUGH OF WOODCLIFF LAKE
MAYOR AND COUNCIL MINUTES
MAY 4, 2020
5:00 PM**

Mayor Rendo stated that the Mayor and Council, Borough Attorney and Borough Engineer are participating via zoom. If you hear background noise, it is because everyone is participating from home. Any questions asked on Facebook will not be answered because Council does not have the benefit of seeing what the questions are. Any comments or questions have to be called in or you could have emailed the Borough Clerk up until 4:30 PM. If you call in, each comment will be limited to 3 minutes. Please be brief in your comments.

CALL TO ORDER

Notice of this meeting, in accordance with the "Open Public Meetings Law, 1975, C. "231", has been posted at the Borough Hall and two newspapers, The Record and The Ridgewood News, have been notified. This meeting is being held via zoom and televised.

ROLL CALL

Mayor Rendo asked for a roll call. Council members Falanga, Gross, Hayes, Singleton and Spelling were present. Borough Attorney John Schettino was present, as well as Borough Administrator Tomas Padilla and Borough Clerk Debbie Dakin. Councilwoman Gadaleta arrived at 5:15 PM.

PLEDGE OF ALLEGIANCE

All present recited the Pledge of Allegiance.

APPROVAL OF MINUTES

Motion to approve the Minutes of April 6, 2020 was made by Councilwoman Gross, second by Councilman Spelling and approved by Councilman Falanga, Councilwoman Gross, Council President Singleton and Councilman Spelling. Councilwoman Hayes abstained since she was not in attendance for the meeting. Councilwoman Gadaleta was absent for this portion of the meeting.

MAYOR'S REPORT

Mayor Rendo asked for a Moment of Silence for the passing of Councilwoman Gadaleta's father-in-law, Councilwoman Hayes' father, former Councilman Paul Camella and all the victims of COVID-19. Mayor Rendo stated that Woodcliff Lake has 108 positive cases of COVID-19 as of yesterday. We did not receive any information of where they come from, the age, race or sex of the victim. Please practice social distancing. Mayor Rendo stated that every week he has a telephone conference with the Governor's office. It is 70 Bergen County mayors, County Executive and representatives from the Office of the Governor. This past week the Mayor asked 2 questions. Mayor Rendo asked about the opening of the ballfields. The answer to that specific question was no. Baseball fields, tennis courts and any active recreation fields shall remain closed. This is a direct order from the Office of the Governor. The County parks are open, but it is a soft opening. Mayor Rendo asked the Governor's office whether to open the pool this summer or not. None of the Executive Orders prevent us from opening the town pool. If we open it up, are there any restrictions. The response was that there are no restrictions to opening the municipal pool; however, that does not mean that a restriction is not coming down the pike. Mayor Rendo stated that he took that to indicate that they are looking at closing municipal pools. Hillsdale is in the same position as us. Mayor Rendo stated that the residents are happy with the co-mingling. It makes it a lot easier for them to recycle. Mayor Rendo stated that there will be a Resolution on the Agenda for the extension of tax payments to June 1, 2020. This is being considered by the Council. If this does pass, you have until June 1, 2020 to pay property taxes but knowing if you pay past June 1, 2020 interest reverts to May 1, 2020.

ENGINEER'S REPORT

Evan Jacobs stated that we received a letter from the DOT that the Glen Road Culvert project received a \$600,000 grant towards the replacement of that bridge culvert. Mr. Jacobs stated that he will be sending in a proposal shortly for the survey work. Mr. Jacobs stated that we are doing a joint road project with Hillsdale for Lincoln Avenue. Woodcliff Lake received a grant from the DOT for approximately \$200,000 to put towards that project. Mr. Jacobs stated that he has been coordinating with Chris Behrens for the 2020 Road Paving program. They identified three roads that need the most attention for various reasons. On the Agenda tonight, is the pool cover bid. Whether or not the pool gets opened this year, you need a functional pool cover that is easy to use. We are still moving forward with that project. There was still some remediation work at Galaxy Gardens that was going on. This should take approximately another week to do that work. As of last week, we received the Treatment Works Approval Permit for both pump stations. We also received the Wetlands Permit for the Glen Road pump station. The Maria Road permit should be coming in another week.

ADMINISTRATOR'S REPORT

Administrator Padilla stated he has had different conversations with Chris Behrens and DPW Council liaisons regarding the ecology center. Chris Behrens joined the meeting via zoom. Mr. Padilla commended Chris and his staff for doing a fantastic job during this crisis. Chris has been

strategically planning. We did put in a temporary solution for our guys to pick up recycling. This can work for a short time but cannot go on forever. The equipment that is being used to pick up the recycling is going to be needed come fall time for leaves. Chris has been looking at different options. We came up with the recommendation that beginning this Saturday, we can begin to open the ecology center on a limited basis. It would be Saturdays and Sundays would be half days for recyclables and cardboard. Only 2 cars will be let in to the fenced in area. On Wednesday, bulky and brush would be allowed. Additionally, this Wednesday, Zone B will have a pick-up for brush. Come June, we will stop doing a recycling pick-up because we are going to be needed to go out and do bulky. Our DPW workers will be needed in other capacities. If we open the ecology center, masks and gloves must be worn by everybody. If you don't have a mask and gloves, you will be turned away. There have been discussions about outsourcing recycling, and Chris will look at those numbers. During the month of May, DPW will still pick up co-mingled up at the curb. Council President Singleton asked Chris Behrens to get some estimates on the cost to co-mingle. Chris stated that he would have to go out for bid for this. Right now, he has 4 guys going out to do co-mingling and this doesn't include every house. Chris stated that you would also have to include tipping fees. He looked at some numbers today and we would probably be looking at \$25,000 - \$30,000 tipping fees. Councilman Falanga stated that it must be communicated with the residents that if they are taking their recyclables to the ecology center, they must be separated. Co-mingling is only temporary and only if DPW is picking it up from their curb. Administrator Padilla agreed that it needs to be spelled out. Councilwoman Gross stated that as much as we all want the ecology center opened, her concern is that it doesn't make a whole lot of sense if residents are dropping off their recyclables separated but we are picking up at their houses co-mingled. It would take a lot more time of everybody to be in the recycling center if they must separate and it is confusing. Councilwoman Gross suggested that maybe you have a schedule for different zones be allowed to use the center on different days. Maybe we won't get stuck in a situation where we have a line of cars stuck with their garbage in their cars. Mr. Padilla stated that we can request different zones, but it is hard to enforce it. We will also have a barricade out and anyone past that barricade at a certain time would be allowed to enter the facility. Councilwoman Hayes stated that after this crisis is over, we need to look at different scenarios for the Mayor and Council to consider going forward. Councilwoman Hayes stated that we are going to have to reimagine. Chris will send a message via constant contact regarding the ecology center being opened this weekend. Chris will send a plan to the Mayor and Council for approval first.

Elizabeth Calderone joined the meeting via zoom. Administrator Padilla stated that as far as pools go, there is no closure yet. That does not mean that there will not be an order going forward. Additionally, there may be restrictions as to the amount of people that will be allowed in. Mr. Padilla stated that we might not be able to have a snack stand at the pool. Another issue is the bathrooms. How often do they have to be cleaned? Last year we allotted a certain amount of money for the repairs at the pool. One of the venues that we could take is to keep the pool closed and use the summer to go out to bid and make those repairs. Camp is a little more optimistic because it is later in the year. If we do open, are we going to receive the revenue. Ms. Calderone stated that it is not looking good for the pool. We normally open Memorial Day weekend and this year we cannot. We are in a holding pattern right now. We have a large pool

and our expenses are up there. If Governor Murphy puts a maximum number of people that we could have at a gathering, we must go back to the chalkboard and revisit again. We would have to come up with another set of rules. Registration and membership come into play. If you have a membership you should be able to come whenever you want. We talked about doing daily passes instead of a membership. How do we keep the staff safe? It is all about health and safety. We would not have a snack bar. Do we have 15-year old kids be responsible for cleaning the bathrooms? Ms. Calderone stated that camp doesn't begin until the end of June and we could possibly push it out until July and do a short camp. How do we keep young children apart if there is a social distancing directive? How do you keep masks on children? Ms. Calderone stated that people are registering for the camp. Administrator Padilla stated that most of the prep work is done by DPW. Because of all the extra work DPW is doing, they will not be able to open the pool. We received an estimate from a pool company for \$30,000 to open the pool. Councilman Falanga stated that a lot of residents might not be travelling this summer, so many people will be home. We wanted to try and offer our residents something. We have been deliberative and careful not to make any definitive decisions until we absolutely must and there is literally no other option. Councilwoman Gross stated that safety, and cost is important but also mental health is important as well. Councilwoman Gross stated that the pool is seeming a little bit dicier for her right now and was more hopeful earlier on. The thing that concerns her is that there is a directive right now on how many people can gather. That is a factor and the other factor is to pay somebody to open the pool up. Additionally, we must give staff notice if we are not planning to open so they could find other employment. Mr. Padilla stated that he believes the pool is very hard to do this year, but we should keep camp as an option. Ms. Calderone stated that there is a lot that needs to be done prior to the pool opening. A discussion took place on different scenarios on how to hold camp for the summer. A discussion took place on when to decide regarding the opening of the pool and camp. Councilwoman Hayes stated that being that schools are closed until the end of this school year, the fixed cost to get everything up and running and not knowing if the Governor is going to impose a new directive, she doesn't believe it would be fair to staff, Elizabeth, and DPW. She believes we should decide and move on at this point so we could finalize our budget. Closing the pool will trigger some things in the budget as well. Administrator Padilla asked if the Park and Recreation Committee which consists of himself, Elizabeth Calderone, Councilwoman Gross and Councilman Falanga could discuss it and make the call in 2 weeks. Councilwoman Gadaleta asked how long it would take DPW to open the pool. Councilman Falanga replied 3 weeks. It was agreed that the Park and Recreation Committee would make the call on May 18, 2020 on whether to open the pool.

COUNCIL MEMBERS' REPORT/COMMENTS

Council President Singleton stated that he would like to give a report on finance. Mr. Singleton stated that there has been a discussion especially on Facebook and email blasts that have been sent out from residents or the Mayor's comments on Facebook about negotiating what we talked about in terms of the budget. Council President Singleton stated that he wants to clear the air here and tell people what we are doing. In terms of negotiations, there are no negotiations between the Mayor, himself, or Councilman Falanga. This is a complete Council decision and is not his decision, the Mayor's decision or Councilman Falanga's decision. We are here to do the

right thing by the town. What we are deciding on is what is the right path going forward. There is a Budget out there that we are going to introduce that calls for a \$12.00 increase per month. Some of the suggestions that he has received from the Mayor and Councilman Falanga is to get this back to not having a tax increase this year. There have been discussions about \$0, \$109 and \$149 increase. Council President Singleton stated that he has asked both our auditor and our CFO if we could do a look out over and above of what we are looking at this year, so we are informed about our decision. Council President Singleton stated that this cannot be a political decision. It must be a decision on what is best for our residents. Tonight, we are going to introduce our budget. The reason why we are introducing is so that the residents can see the budget. That doesn't mean that this is the final number. This means that we are going to start having discussions over the next 4 weeks. Hopefully, next week Council President Singleton gets the numbers for what next year and the following year will look like. He plans to share the information with the Mayor and Council and residents. To decide today that we are going to have a zero-tax increase without looking into the future, Mr. Singleton thinks is irresponsible of the Mayor and Council. If people call in regarding specific line items, Mr. Singleton does not know how you are talking about specific line items because we haven't introduced the budget yet and nobody should have seen it until after it is introduced. It will be on our website after tonight's meeting. Council President Singleton stated that he is available to speak with anybody regarding the budget. Councilwoman Gadaleta thanked Council President Singleton for sharing that with everyone. Councilwoman Gadaleta asked Mr. Singleton what the original tax increase number that was given to us by our auditor and CFO. Council President Singleton stated that they originally came back to us with a \$260 tax increase. Mr. Singleton asked them to cut that back down and they cut \$275,000 in expense in that number to bring us down to the \$148 which is where we are today. Councilman Falanga stated that we try and maintain a zero percent tax increase. He does not suggest it has to be zero. He suggested that that should be our goal and try and maintain last year's taxes. Councilman Falanga stated that one thing that is not in the budget that he is concerned about is that we are not budgeting to redo the Master Plan. This is vital to the Borough to take care of. He understands that this might be done by Resolution and he believes that is a mistake. Especially in light of the current litigation, it is vital that we complete our Master Plan this year, so we do not open up the possibility of builder's remedy type lawsuits. If this is his only chance to comment on this, he wants to get it on the record. Council President Singleton asked Mr. Padilla how much it would cost to put the Master Plan in the budget. Mr. Padilla replied approximately \$60,000. Mr. Padilla stated that we did a re-examination last year, so we do have coverage for builder's remedy. The consensus is that we should pursue a Master Plan. We looked at that with our financial professionals, and their suggestion would be to wait until after the budget is passed and do an emergency appropriation because that will allow us the ability to do that cost over the following 5 years as opposed to take a one-time hit for \$60,000. Council President Singleton asked Mr. Padilla if the intent would be to do it this year. Mr. Padilla replied yes. Councilman Falanga asked Mr. Padilla if we would be paying the planner this year. Mr. Padilla replied that the CFO would be better off explaining this and he could have him call tomorrow. Mr. Padilla stated that he does not know how long it would take the planner to complete the Master Plan. Councilwoman Hayes stated that we had Mr. Preiss come to a meeting last year and she believes we are compliant with the re-examination. She would like to hear an update if we are not compliant and at risk for a builder's remedy. If we want to try and

work this budget as close to zero as possible, that \$60,000 nut should be rethought if we are not at risk for a builder's remedy suit. Councilwoman Gross stated to Mayor Rendo that she is hearing that he is having virtual meetings with the Governor and other Mayors and that is fantastic. However, we as a Council body, could be informed as to what is discussed during these meetings. She would like to understand our numbers and understands HIPPA regulations but would love to have some accurate numbers. Councilwoman Gross also stated that she finds out information by looking at it on Facebook but would appreciate it if the Council could learn from you before reading something on Facebook. Mayor Rendo replied that the numbers are recorded by the County and every municipality is struggling with finding out where these numbers are coming from. We are only given number of positive cases; we are not given information as to where they are coming from. Councilwoman Gross stated that the bulk of her frustration is communication amongst our Governing Body and how important it is as leaders of the Community that we are informed of what is going and what you learned and know and that you share it with us instead of each one of us individually reaching out to Mr. Padilla. It is embarrassing to have somebody call us to tell us something that they saw on Facebook that the Council has not yet been made aware of. Mayor Rendo replied that he understood. Council President Singleton stated that when everybody gets a change, he asks that the Mayor and the Council email him and let him know what their suggestions for reductions are.

**A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS
OF THE NEW JERSEY OPEN PUBLIC MEETINGS, ACT, N.J.S.A. 10:4-12**

**RESOLUTION NO. 20-121
MAY 4, 2020**

WHEREAS, the Borough of Woodcliff Lake is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq., and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Borough of Woodcliff Lake to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

____ 1. Matters Required by Law to be Confidential. Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

____ 2. Matters Where the Release of Information Would Impair the Right to Receive Funds. Any matter in which the release of information would impair a right to receive funds from the Government of the United States.

____ 3. Matters Involving Individual Privacy. Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.

____ 4. Matters Relating to Collective Bargaining Agreements. Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.

____ 5. Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds. Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed specifically with respect to _____. The minutes will be released on or before _____, 20__ when the issues pertaining to the property located at _____ have been approved and finalized.

____ 6. Matters Relating to Public Safety and Property. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

X 7. Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege, any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer, specifically with respect to: Litigation Update.

The minutes will be released in approximately ninety (90) days or upon the resolution through settlement or court decision and the time period for any and all appeals.

____ 8. Matters Relating to the Employment Relationship. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely

affected request in writing that such matter or matters be discussed at a public meeting, specifically: personnel discussion.


The minutes will be released within ninety (90) days or earlier upon the resolution of the matter through settlement or court decision and the time period for any and all appeals.



Hello Mr. Padilla:

Last evening I contacted Mayor Rendo about a request I submitted on April 16 for the Mayor & Council to consider (see emails below). He said he did not recall if my request was communicated to the Mayor & Council and advised me to submit it to you for inclusion in the discussion of this matter at the next Mayor & Council Meeting of 5/4/2020 at 5 PM. Would you please provide this communication to the Governing Body, prior to the discussion of this matter, and include it in the record of the meeting.

I am formally requesting that the Woodcliff Lake Mayor & Council extend the grace period for property tax payments to the end of May without interest or penalty assessments, as many, many New Jersey municipalities have done (see below). This is an extremely difficult time for all of us and any assistance would be meaningful - especially financial assistance.

As a previous 3-term Woodcliff Lake Councilperson, I certainly understand and appreciate the many difficult decisions and responsibilities of our borough's elected officials. I also understand that extending such a tax grace period would have an extremely small impact on the Borough as a whole, and yet, be a meaningful help to your Woodcliff Lake residents dealing with this extremely difficult situation.

Therefore, I formally request the Mayor & Council approve the grace period for property tax payments to May 31, without interest or penalty. With this action, you take another step in confirming your care and concern for the residents during this crisis.

ORDINANCE 20-02

BOROUGH OF WOODCLIFF LAKE

CALENDAR YEAR 2020

**ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO
ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Council of the Borough of Woodcliff lake in the County of Bergen finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and Council hereby determines that a 1% increase in the budget for said year, amounting to \$101,181 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

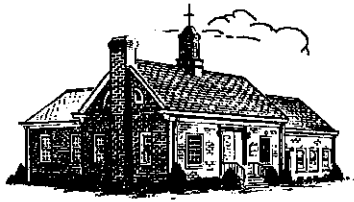
WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Woodcliff Lake, in the County of Bergen, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the Borough of Woodcliff Lake shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 1%, amounting to \$101,181 and that the CY 2020 municipal budget for the Borough of Woodcliff Lake be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS, ACT, N.J.S.A. 10:4-12

RESOLUTION NO. 20-121

MAY 4, 2020

WHEREAS, the Borough of Woodcliff Lake is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq., and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Borough of Woodcliff Lake to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

_____ 1. Matters Required by Law to be Confidential. Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

_____ 2. Matters Where the Release of Information Would Impair the Right to Receive Funds. Any matter in which the release of information would impair a right to receive funds from the Government of the United States.

_____ 3. Matters Involving Individual Privacy. Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing,

relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.

____ 4. Matters Relating to Collective Bargaining Agreements. Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.

____ 5. Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds. Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed specifically with respect to _____. The minutes will be released on or before _____, 20__ when the issues pertaining to the property located at _____ have been approved and finalized.

____ 6. Matters Relating to Public Safety and Property. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

X 7. Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege, any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer, specifically with respect to: Litigation Update.

The minutes will be released in approximately ninety (90) days or upon the resolution through settlement or court decision and the time period for any and all appeals.

____ 8. Matters Relating to the Employment Relationship. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting, specifically: personnel discussion.


The minutes will be released within ninety (90) days or earlier upon the resolution of the matter through settlement or court decision and the time period for any and all appeals.

_____9. Matters Relating to the Potential Imposition of a Penalty. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.
