


NOTICE TO WOODCLIFF LAKE DOG AND CAT OWNERS

The 2020 Rabies Clinic for dogs and cats will take place on Saturday, January 11, 2020 from 11:00 a.m. to 1:00 p.m. at the Borough Hall for licensing and at the Fire House for rabies shots.

Dog and cat licenses must be obtained by January 31, 2020. All dogs and cats over 7 months of age are required to be licensed in the Borough of Woodcliff Lake. A canvass will be made after this date, and owners of unlicensed animals will be subject to the penalty as provided by law. There will be a late fee of \$10.00 in addition to the regular licensing fee after February 28, 2020. After March 31, 2020 a summons will be issued to owners who have not registered their pets.

Licenses may be obtained at the Borough Hall or by completing the attached application cards and mailing same with a check for the appropriate amount, together **WITH A COPY OF A VALID RABIES CERTIFICATE** proving rabies vaccine is valid through October 31, 2020.
